Sixty-Seventh Session

First Day

St. Paul, Tuesday, January 5, 1971

This being the day designated by the Constitution and Laws of the State of Minnesota for the assembling of the Legislature, the members-elect of the Senate met in the Senate Chamber of the Capitol and were called to order at 12 o'clock noon by Rudolph G. Perpich, President of the Senate.

Prayer was offered by Reverend John O'Neill.

Oscar Knutson entered the chamber and began to administer the oath.

Prior to administration of the oath, Mr. Coleman raised a privileged point of order, requesting that the President direct that the oath not be administered to Mr. Palmer or Mr. Overgaard, pending the determination by the Senate of their respective election contests.

The President then appointed Mr. Gearty Secretary Pro Tem.

After discussion, the President ruled, with respect to Mr. Palmer, that he not be administered the oath, nor be seated, pending determination of his election contest by the Senate. In the case of Mr. Overgaard, the President ruled that Mr. Overgaard be administered the oath, and be permitted to take his seat.

Mr. Holmquist appealed the ruling of the Chair, as it related to Mr. Palmer.

Mr. Coleman offers the following resolution:

BE IT RESOLVED, that the permanent rules of the Senate for the Sixty-seventh session be adopted as the temporary rules of this session to be effective until the adoption of permanent rules by a majority vote of the Senate, subject to the following conditions.

That every member of the Senate who has not been excused who shall be in the Senate when the question is put shall give his vote unless the Senate, for special reasons, shall excuse him. A motion by a member to excuse himself from voting shall be made before the Senate divides or if the roll is called, before he casts his vote. Any member wishing to be excused from voting may make a brief statement of the reason for making such request and the question shall be taken without further debate.

Upon motion by a member with respect to another member, a majority of the Senate may excuse the other member from voting if he has had an opportunity to vote and has failed to do so and such motion shall have precedence over all other motions and shall be in order during a roll call or during a call of the Senate.

That Rules 22, 53, 54, 62, and 69 shall not be operative, and that any resolution or other question before the Senate may be brought to a vote at any time by a majority vote of the Senators present, and no bill shall be introduced the first day.

SENATE CONCURRENT RESOLUTION NO. 1
