

Mr. Snyder offered the following—

RESOLUTION.

Resolved, by the Senate, the House concurring, that a certain Resolution adopted by the Senate, the House concurring, on February 4th, 1893, be and the same is hereby amended to read as follows:—

Be it Resolved by the Senate, the House of Representatives concurring, that the pink and white Lady Slipper, or Moccasin Flower, *Cypripedium Reginae* be and the same is hereby designated and adopted as the State flower or floral emblem of the State of Minnesota.
