LEGISLATIVE ADMINISTRATION AND RULES MEETING

Minutes of Meeting January 9, 1969

The meeting was called to order by the Chairman, Mr. Dirlam at 11:00 A.M. The following members were present:

The accreditation of the press was discussed but was postponed until such time as all requests have been received.

Mr. Renner made the motion, seconded by Mr. Frenzel and unanimously carried: Pursuant to House Rule 58 the compensation for the Director of House Research, Mr. Tom Clifford would be \$50.00 per day- Assistant Director of House Research, Vernelle L. Clayton - \$24.00 per day; Research Assistants Ron Ruud, John Ellefson and Don Cleveland at \$32.50 per day. Steve Szarke \$30.00 per day (to be paid by the House the first half of the session and the Senate the second half of the session). Jack So, John Williams at \$30.00 per day. Steve Harrington at \$22.00 per day. John Williams at \$25.00 per day, these are to be reveiwed during the Session.
